The effluent treatment plant removes suspended solid matter (as sludge) and floating oils from the wastewater. The remaining emulsified oil is removed by chemical treatment using hydrochloric acid and aluminum sulfate. Lime is added to neutralize the wastewater prior to discharge to the municipal sewer.
